As a member of a minority group in this country, I am fully aware of the covert inequities of that certain subcultures face because they are "different". I am specifically writing to request that you people reconsider your decision not to admit Bhagwan Shree Rajneesh to the U.S. as a permanent resident on a Religious teacher VISA permit. I do not understand how you could deny him admission to this country.
